O R D E R

1. Heard Mr. Sudhanshu Choudhari, learned senior

counsel for the petitioner, Mr. Vikas Yadav, learned counsel for the *de-facto* complainant-respondent no.2 and Ms.Neha Singh, learned counsel appearing on behalf of Ms.Swati Ghildiyal, learned AOR for the State.

2. Mr. Sudhanshu Choudhari, learned counsel for the petitioner, submits that the principal charge is under 108 of the Bharatiya Nyaya Sanhita, 2023 (for short, 'BNS'). He further submits that it was the petitioner who removed the deceased to the hospital.

3. Accordingly, pending further consideration of the petitioner before this Court, the petitioner shall be enlarged on interim bail in connection with FIR/CR No.11196007250592 dated 31.10.2025 registered with Gorwa Police Station, Vadodara, Gujarat, for the offences punishable under Sections 85, 351, 108, 54 of the BNS and Sections 3 & 4 of the Dowry Prohibition Act, subject to the satisfaction of the concerned Trial Court.

4. Let the matter be listed for further consideration on 18th May, 2026.
