This petition for transfer is filed by the wife seeking transfer of the petition filed by the husband under Section 5, 7 and 12(1)(c) of The Hindu Marriage Act, 1955 from the court of Additional District Judge(HMA), Karkardooma Court, Delhi to the court the District Judge,, Chapra (Saran), Bihar.

The petitioner has alleged that she is not in a position to take up frequently long travel from her place of residence in Chapra, District Saran, Bihar to Delhi to attend to the case and there is no one to accompany her; That her petition for restitution against her husband is pending in the court of the District Judge Saran (Chapra) also. In the circumstances, we consider this a fit case for transfer.

We therefore allow this petition and transfer Matrimonial Petition No.36 of 2009 (Rajnish Kumar Verma vs. Kumari Meera) pending on the file of the Additional District Judge(HMA), Karkardooma Court, Delhi to the court of District Judge, Chapara, (Saran), Bihar who may deal either deal with it or transfer it to the Family Court if a separate Family Court exists.
