CA NO. 8848 of 2011

CA NO. 8849 of 2011

CA NO. 8851 of 2011

There are 5 Respondents. Respondent No. 1 is represented by Ms. Anubha Agarwal, Advocate. Respondent No. 3 is reported dead. Counsel for the appellant has filed an application for substitution to bring on record the Lrs. of deceased Respondent No. 3 which is found to be defective for various reasons. Counsel for the appellant was asked vide this registry's letter date 19.02.2013, 18.03.2013 and 21.05.2013 to cure the defects, but counsel has not done the needful till date. Respondent No. 2, 4 and 5 have been served with notice but has not chosen to enter appearance. Service of notice is complete.

CA NOS. 10201, 10202 AND 10203 OF 2011:-
