O R D E R

This petition is filed by the wife seeking transfer of the divorce petition filed by the husband under Section 13 of the Hindu Marriage Act, 1955, pending before the Family Court at Bandra, Mumbai to the Family Court at Ernakulam, Kerala. The petitioner alleges that the respondent has filed the petition as a counterblast to her petition for divorce; that the petitioner is unemployed and is dependant on her parents and she is not in a financial condition to undertake visits to Mumbai to defend the case; that the petitioner apprehends threat to her life at Mumbai.

2. In the facts and circumstances, we consider this a fit case for transfer.

Accordingly, Transfer Petition is allowed and Petition No1308/2010 titled as "Teemeer Chimulkar vs. Shweta Chimulkar" pending before the Family Court at Bandra, Mumbai is ordered to be transferred to the Family Court at Ernakulam, Kerala, to be taken up with O.P. No.851/2010 (Shweta Asher vs. Teemeer Chimulkar) and O.P.No.1082/2010 (Shweta Asher vs. Teemeer Chimulkar) pending on its file.
