have been continued thereafter. The aid should have been continued and particularly in the light of the decision of this Court. Therefore, we think in the special features of this case the order made by the High Court should be set aside and the aid granted to the school pursuant to the order made on 24.11.1994 should be continued.

The learned counsel for the respondents, however, pointed out that the grant-in-aid Rules have been repealed now. Whether it is so or not and what its effect is need not be examined in the present case. That question is left open.

In the light of what we have said, the order of the High Court is set aside and there shall be a direction to the respondents to continue with the aid granted to the appellant in terms of the order dated 24.11.1994 and subject to Rules. The appeal is allowed accordingly. However, there shall be no order as to costs.
