UPON hearing counsel the Court made the following  
O R D E R

Mr. Jaspal Singh, the learned senior counsel  
for the petitioner on instructions from his client  
through Mr. Vipin Gogia, learned counsel states  
that a sum of Rs. 50 lakhs will be paid by way of

bank draft to the complainant-Gyan Steel Rolling  
Mills Private Limited in two equal instalments of  
Rs. 25 lakhs each out of which one shall be payable  
within a period of six weeks from today and the  
second instalment within six weeks thereafter

without prejudice to the petitioner's claims in the civil Suit as also in the present proceedings.

We find that the statement made by the learned counsel is very fair. We, accordingly, make an order in the above terms.

We direct that in case the petitioner is arrested in the present proceedings, he shall be released on bail to the satisfaction of the Arresting officer.

We clarify that a default in payment of any one of the aforesaid instalments would lead to the cancellation of the anticipatory bail granted to the petitioner.

The Special Leave Petition is disposed of in the aforesaid terms.

Copy of the order be supplied to the complainant as soon as possible through the Registrar of the High Court of Punjab and Haryana at Chandigarh as well.
