These petitions are directed against the order of the Division

Bench of the Punjab and Haryana High Court which, after threadbare analysis of the pleadings of the parties, various reports filed by the committees appointed pursuant to the interim orders passed during the pendency of the writ petitions and the affidavit of the Financial Commissioner, came to the conclusion that selective release of the acquired land in favour of certain individuals amounted to discrimination qua the petitioners.

In our view, the finding recorded by the High Court does not suffer from any legal error and the impugned order does not call for interference by this Court.

The special leave petitions are accordingly dismissed.
