O R D E R

Petitioners (Indian Oil Corporation) has filed two writ petitions before the Allahabad High Court (Writ Petition No.46115/2002 and W.P.No.4540/2003) raising the question whether 'stationary storage tank' installed by the petitioners for the purpose of storing the liquid products, are 'measures' within the meaning of Standards of Weights and Measures Act, 1956. The petitioner alleges that several other cases raising the same issue has been transferred to this court vide order dated 10.3.2006 in Transfer Petition (civil) No.874/2004 and connected cases. As similar issue is seized by this Court, we consider these petitions are also fit cases for transfer.

We accordingly allow these petitions and direct transfer of Civil Misc.W.P.No.46115 of 2002 and Civil Misc.W.P.No.4540 of 2003 pending on the file of Allahabad High Court, to this Court to be taken up with the matters which have already been transferred in pursuance of order dated 10.3.2006 in T.P.(C) 874/2004.
