SLP(C) No. 12696/2024

Four weeks time, is granted to respondent Nos. 1 and 3 and 5 to 9 to file counter affidavit.

Ld. Counsel for Respondent No.2 submits that yesterday counter affidavit has been filed on behalf of said respondent. Registry to verify the same and update the records.

Respondent No.4 has already filed counter affidavit.
