O R D E R

On account of sincere endeavour made by Mr. Gunwant Dara, Mediator, Supreme Court of India, Parties have iron out their differences. Same are reflected in the Settlement Agreement arising from mediation proceedings between the parties. On 9.11.2011, Agreement, duly signed by both the parties and their Advocates, has been arrived at. We appreciate the efforts made by the

learned Mediator.

Today Mr. Ashok Mathur, learned counsel appearing for the petitioner, handed over ten demand drafts for a total sum of Rs.22,00,000/- (Twenty two Lakhs), as per the details given in Annexure 'A', forming part of the order, to Ms. Sunita Sharma, learned counsel appearing for the respondent, who has accepted the same.

The aforesaid amount of Rs.22,00,000/- is towards full and final settlement and all dues towards the respondent as well as the child. All other cases between

the parties would stand quashed or withdrawn.

Thus, a decree of divorce is passed in favour of the parties on the terms and conditions as mentioned in the Settlement Agreement, which will also form part of this order.

With the aforesaid directions, this special leave petition stands disposed of.
