O R D E R

This petition for transfer is filed by the petitioner-wife seeking transfer of the petition filed by respondent-husband for declaration that the marriage is a nullity from Tambaram, Chennai to Anantapur (Andhra Pradesh). It is stated that the petitioner-wife is unemployed and is dependant on her elderly parents. She has no source of income to travel to Tambaram, Chennai to defend the case. The petition filed by the petitioner for restitution of conjugal rights is pending before the Family Court, Ananthapur. The respondent has contested the

petition.

2. Having considered the facts and circumstances and the hardship pleaded, we consider this a fit case for transfer.
