UPON hearing the counsel the Court made the following
O R D E R

1. Pending disposal of the order passed by the Civil Court under Section 9 of the Arbitration and Conciliation Act, 1996 (for short, 'the Act') on 22.07.2025, as modified by the order impugned under

Section 37 of the Act on 02.04.2026, we are informed that the arbitral proceedings have commenced.

2. In view of the fact that, the arbitral proceedings have commenced, it would be appropriate that the Arbitral Tribunal takes up the application under Section 17 of the Act and pass appropriate orders after hearing both the parties. The orders that may be passed by the Arbitral Tribunal will accordingly modify the directions in the order impugned before us.

3. We make it clear that we have not expressed any opinion on the merits of the matter. It is for the Tribunal to arrive at its own decision to balance the interests of both parties under Section 17 of the Act.

4. With these clarifications, the Special Leave Petition stands disposed of.

5. Pending application(s), if any, shall stand disposed of.
