O R D E R

1. On the oral request of learned counsel for the petitioner, let CBI, ACB, Jaipur, which is the investigating agency, be impleaded as a party. Let the amended memo of parties be filed within a week.
2. The petitioner seeks pre-arrest bail in connection

with FIR No.RC0302025A0011 registered at Police Station- CBI, ACB, Jaipur for offences under Sections 419, 420, 468, 471 and 120B of the Indian Penal Code and Section 7 of the Prevention of Corruption Act, 1988.

3. Learned counsel for the petitioner submits that the petitioner is presently working and that the FSL report has also gone in his favour.

4. Records indicate that the FSL with regard to the photographs have gone in favour of the petitioner but we would like to know about the FSL with regard to the thumb impression.

5. Since the petitioner is working, at this stage we are inclined to grant interim protection to him till the next date of hearing.

6. In the event of his arrest, he shall be released on bail subject to such terms and conditions to the satisfaction of the Investigating Officer, in connection with FIR No.RC0302025A0011 registered at Police Station- CBI, ACB, Jaipur for offences under Sections 419, 420, 468, 471 and 120B of the Indian Penal Code and Section 7 of the Prevention of Corruption Act, 1988.

7. Issue notice, returnable on 21.05.2026.

8. Let a copy of the Paper Book be supplied to Mr. S.D. Sanjay, learned Addl. Solicitor General, present in the Court who may take instructions.

9. The petitioner shall participate and cooperate with the investigation.
