O R D E R

These petitions are directed against interlocutory orders dated 26.7.2011 and 10.8.2011 passed by the Division Bench of the Delhi High Court in Writ Petition (Civil) No.5237 of 2011.

We have heard the learned Solicitor General appearing for the petitioners, Shri Soli J. Sorabjee, learned senior counsel appearing for the respondent and Shri M.L. Verma and Shri S.B. Upadhyay, learned senior counsel appearing for the intervenors and are of the view that ends of justice will be adequately served by requesting the High Court to take up (Civil) No.5237 of 2011 and all connected matters on priority basis, hear the same on 29.8.2011 and make an endeavour to dispose of the matters as early as possible.
