Mr. Harish N. Salve, learned Senior Counsel appearing for the petitioner submits that charge sheet has now been filed. We direct that further proceedings be carried out by the Central Bureau of Investigation Court without being influenced by any observations made by the High Court.
The Special Leave Petition stands disposed of in the aforesaid terms.

Mr. H.P. Raval, learned Additional Solicitor General submits that the period for investigation has not been restricted and that the Central Bureau of Investigation has in fact investigated the matter since the year 2001. In this view of the matter, no further directions are necessary.

The Special Leave Petition is dismissed.
