8. List the matter along with Mediation Report on 07.08.2026.

In the meanwhile, the operation and effect of summoning order dated 29.10.2025 passed by the Additional Chief Judicial Magistrate, Ghaziabad, in Complaint Case No. 440 of 2025 and impugned final judgment and order dated 22.01.2026 passed by the High Court of Judicature at Allahabad in Criminal Miscellaneous Application No. 190 of 2026 shall remain stayed.
