This is a petition filed by wife under Section 25 of the Code of Civil Procedure for transfer of O.P. No.528 of 2011 filed by husband from Family Court, Thiruvalla (Kerala) to a Court of competent jurisdiction at Mumbai.

We have heard learned counsel for the parties and perused the record.

In the petition, wife has averred that they have a girl daughter, aged about 4-5 years, who is suffering from heart ailment having hole of 6 mm.

For the said reason, we are satisfied that it is a fit case for transfer and O.P. No.528 of 2011 titled "George Jacob Vengal versus Reeba Cherian" pending in the Family Court, Thiruvalla should be transferred to the Court of District Judge, Mumbai, who may try the case himself or make over the
