Submissions on various aspects of grant of premature release in terms of the note submitted by the learned Amicus Curiae are heard and the order is reserved.

Now, the Court will have to consider compliance reports submitted by the States of Jharkhand, Meghalaya, Maharashtra, Punjab, Rajasthan, Bihar, Delhi and Uttar Pradesh.

We direct the aforesaid States to submit their fresh compliance reports to the learned Amicus Curiae by the end of this month. We grant time to the learned Amicus Curiae to compile the same. The issue of compliance by these States will be considered on 17th February, 2025 at the end of the cause list.

As far as the issue regarding Portal is concerned, this Court will consider the same on 27th January, 2025 at the end of the cause list.
