## O R D E R

Five transfer petitions have been listed before us for consideration today. Of the said five matters, Transfer Petition (Civil) No.73 of 2009, has become infructuous on account of the fact that the writ petition (being SCA No.17825 of 2006), pending before the Gujarat High Court, has since been disposed of by the Gujarat High Court.
