UPON hearing the counsel the Court made the following
O R D E R

1. The petitioner challenged the judgment and order dated 08-04-2026 in CRMABAU482BNSS No. 576/2026 passed by the High Court of Judicature at Allahabad, Lucknow Bench.
2. Issue notice, returnable on 20.07.2026.
3. Ms. Ruchira Goel, learned counsel, accepts notice on behalf of the State.
4. Notice be issued to Respondent No. 2. Dasti service, in addition, is permitted.

5. In the notice itself, let it be mentioned that Respondent No.2 is required to file a counter affidavit and reply to the interlocutory application(s), if any, before the next date of listing.

6. Rejoinder thereto, if any, be filed within two weeks thereafter.

7. In the event of arrest in connection with FIR No. 525 dated 19.11.2025, registered at Police Station Jalalpur, Ambedkar Nagar, the petitioner shall be released on bail by the Investigating/Arresting Officer on such terms and conditions as imposed and found to be just, fair and reasonable. However, in the attending facts, one of the conditions shall necessarily be that if the petitioner possesses a Passport, the same shall be deposited before the Competent Authority/Court, until the conclusion of the Trial or unless directed otherwise.

8. The petitioner shall make himself available before the Investigating Officer on 25.05.2026 at 10:00 a.m. and on all such dates as they may be required.

9. Needless to add, till the investigation is not complete in all respects, the petitioner would fully cooperate, and if the challan/charge sheet is filed, he would maintain good conduct and not attempt to influence any of the witnesses in any manner till the completion of the trial.
