UPON hearing counsel the Court made the following

ORDER

I.A.Nos. 462 :

The lease granted in favour of the applicant appears to have expired. Registration certificate as a small scale industry, also stands cancelled since 1986. Applicant itself filed an application for restoration of the said registration. It, however, appears that despite the same, the applicant has been operating from 1986 onwards.

By an order dated 27.8.1993, this Court had directed closure of all units. It is a matter of surprise that despite the same, the applicant is said to have been continuing to operate its units. The District

Industrial Center in its counter affidavit has categorically stated that the machinery installed in the said unit have become junk and, in any event, it is not possible for it to supply gas to the said unit. Our attention has also been drawn to the fact that Micro, Small and Medium

Entrepreneurs Development Act, 2006 has since been enacted in terms whereof the applicant must get itself registered with the National Board. The application is dismissed.
