O R D E R

1. The Petitioner - wife has filed this Petition under Section 25 of the Code of Civil Procedure with the prayer for transfer of H.M.A. No.245 of 2010 titled as "Amit Kumar vs. Anuradha" pending before the Additional District Judge, Tis Hazari Courts, Delhi to the Court of Additional District Judge, Shiv Puri, Madhya Pradesh.

2. On earlier occasion, we had thought it fit and proper to refer the matter to the Supreme Court Mediation Centre with a fond hope that the matter may be settled amicably between the parties.

3. The Mediator's Report is already placed on record and the same has failed.

4. Thus, having heard learned counsel for the parties and after having gone through the Transfer Petition, we deem it fit and proper to transfer the matter to the Court of Additional District Judge, Shiv Puri, Madhya Pradesh. We order accordingly. The parties are directed to appear before the said Court at Shiv Puri, Madhya Pradesh on 31.07.2012 and the Additional District Judge, Tis Hazari Courts, Delhi, is directed to remit the record to the said Court forthwith.

6. The Petitioner - wife would file her Written Statement, if she has not filed already, within fifteen days from the date, she puts in appearance on 31.07.2012. The Court, thereafter, would frame issues and decide the suit itself as expeditiously as possible and preferably within a period of nine (9) months from the date of framing of the Issues. It is also expected that none of the parties would seek undue adjournment of the matter.

7. Office is directed to send the copies of the order to the Courts at Tis Hazari Courts (Delhi) and Shiv Puri (Madhya Pradesh) both.

8. The Transfer Petition is allowed in the above terms.
