Of deceased respondent No.1(c) i.e. Devender Sharma alongwith condonation of delay in filing of substitution application for condoning 142 days (Regd. as I.A. No. 4-5). Counsel has on 24.06.2014 filed notice of motion for issuing notice to all LRs of deceased respondent No. 1(c) and notice of motion returnable for 25.08.2014 were issued to LRs of deceased respondent through counsel but service report is awaited.

Original Record has been received from the High Court.

Civil Appeal is not ready.
