5. The parties have favourably responded to the suggestion of the Court that an amicable solution be explored through the process of mediation.

6. Let the matters be referred to the Supreme Court Mediation Centre. Parties to appear before the Coordinator, Supreme Court Mediation Centre on 29th May, 2026 at 11.00 a.m.

7. The first meeting with the coordinator shall be virtual. The learned Mediator appointed by the Supreme Court Mediation Centre is requested to conduct the proceedings, as far as possible, through the medium of video conferencing.

8. In the event, the learned Mediator desires personal presence of the parties, they shall undertake to appear physically.

9. Since the matters are referred for mediation, both the learned Senior Counsel/Counsel for the parties submit that their clients will make a request to the High Court to adjourn the appeal(s) to await the outcome of the mediation.

10. Call on 14th August, 2026 after receipt of the report from the Mediator.
