**UPON hearing the counsel the Court made the following
O R D E R**

- 1. Permission to file Special Leave Petition is granted.**
- 2. The present Special Leave Petition is against the interim order of the High Court of Judicature at Allahabad in the contempt proceedings whereby after framing the charges against the petitioner under sections 10 and 12 of the Contempt of Courts Act, 1971, he is directed to remain personally present before the Court.**

3. We are informed by Mr. P.N. Misra, learned senior counsel appearing for the petitioner that against the main order dated 08.07.2025, the State has already filed a review application and the same is pending consideration. He would further submit that in SLP (C) No. 12062 of 2024, this Court while disposing of the Special Leave Petition directed stay of the contempt proceedings till the adjudication of the review petition is completed.

4. Having heard the learned senior counsel and having considered the facts and circumstances of the case, we are of the opinion that while disposing of the instant Special Leave Petition, orders similar to that of SLP (C) No. 12062 of 2024 can be passed. Accordingly, we direct that the contempt proceedings be postponed till the final adjudication of the review application is completed. In the meanwhile, we request the High Court to take up and dispose of the Review Petition(s) expeditiously.

5. We make it clear that we have not expressed any opinion on the merits of the matter. It is for the High Court to consider and pass appropriate orders.

6. With these clarifications, the Special Leave Petition and the accompanying interlocutory application(s), if any, stands disposed of.
