UPON hearing the counsel the Court made the following  
O R D E R

1. Our order dated 09.01.2026 reads thus:-

*"1. Heard the learned counsel appearing for the petitioner.*

*2. Application seeking permission to file the Special Leave Petition is granted.*

*3 Exemption Application is allowed.*

*4. Having heard the learned counsel appearing for the petitioner and having gone through the materials on record, we are of the view that no error not to speak of any error of law could be said to have been meted out by the High Court in passing the impugned order.*

*5. The High Court has granted time upto 31-1-2026 to the petitioner - herein to vacate the suit land and handover possession of the same to the respondents.*

*6. The only indulgence we are inclined to grant is to extend the time upto 31-5-2026 to vacate the suit land.*

*7. We direct the petitioner - herein to file an affidavit on oath in the form of an undertaking that the possession shall be handed over to the respondents on or before 31-5-2026.*

*8. Let such an Undertaking be filed with the Registry of this Court within a period of one week from today.*

*9. With the aforesaid, the Special Leave Petition stands disposed of.*

*10. Pending applications, if any, also stand disposed of."*

2. By our order referred to above, we have granted time to the petitioner to vacate the suit land on or before 31.05.2026.

3. By this application, the applicant prays for some further time saying that he has already started with the construction of a new petrol pump at some other place. We grant further three months to vacate the premises.

4. The petitioner shall hand over vacant and peaceful

possession of the suit land on or before 31.08.2026. He shall file an undertaking on Oath with the Registry of this Court within a period of one week from today stating that he shall hand over vacant and peaceful possession of the suit land on or before 31.8.2026.

5. With the aforesaid, the Miscellaneous Application stands disposed of.

6. Pending application(s), if any, stands disposed of.
