O R D E R

We have heard Mr.Soli J.Sorabjee and Mr.Mukul Rohtagi, learned senior counsel appearing on behalf of the petitioners and Mr.K.K.Venugopal and Mr.P.Vishwanatha Shetty, learned senior counsel for the respondents.

The High Court, by the impugned order, have clearly stated that whatever

expression they have made in the course of the impugned order is only for the purpose

of disposing of the application filed by the respondents therein for vacating the stay and

that would not come in the way of the High Court while deciding the Writ Petitions

and Writ Appeals on merits. The High Court by the said order posted the Writ

Petitions and the Writ Appeals for final hearing in the week commencing from 1st of

December, 2006. It is stated that the matters were not taken up for hearing on

01.12.2006. Since some urgency is expressed by both sides, we request the High Court

to take up the Writ Petitions and the Writ Appeals and dispose of the same on priority

basis before the Court closes for Christmas Holidays.

In the meanwhile, status quo shall be maintained by the both parties.

Both parties will not ask for any adjournment before the High Court.

The Special Leave Petitions stand disposed of accordingly.
