O R D E R

On 13.11.2009, this Court had passed the following order:

"Delay condoned.

The learned counsel for the petitioner on instructions from the petitioners says that he will deposit a sum of Rs.10,000/- per private respondent within a period of two months from today so that the same can be paid to the said respondents as fare to reach in this Court. Issue notice.

We clarify that in case the amount is not deposited within the period fixed, the SLPs will be deemed to be dismissed."

Since the petitioner failed to comply with the condition incorporated in the aforesaid order, the special leave petitions

stood automatically dismissed.

Now, the petitioner has filed applications for restoration of the special leave petitions along with applications for condonation of 429 days' delay.

We have perused the averments contained in the two applications and are satisfied that the petitioner has failed to make out a case for condonation of delay.

Accordingly, the applications for condonation of delay are dismissed. As a sequel to this, the applications for restoration of the special leave petitions are also dismissed.
