UPON hearing the counsel the Court made the following
O R D E R

1. The instant special leave petition is directed against an interim order dated 15.05.2026 passed by a Vacation Bench of the Bombay High Court, in terms whereof, the interim stay on the tender

cancellation corrigendum dated 29.04.2026 has been declined. We find the interest of the petitioner has been safeguarded with the twin conditions that the petitioner may participate in the fresh tender process without prejudice to its rights and that the fresh tender floated by the first and second respondents on 29.04.2026 shall be subject to the outcome of the writ petition.

2. The matter is now listed before the High Court on 08.06.2026.

3. We have heard Shri Mukul Rohatgi, learned Senior Counsel, on behalf of the petitioner and Shri Shyam Divan, learned Senior Counsel, on behalf of the Maharashtra State Road Development Corporation. We are informed that the last date of submission of a fresh tender is 29.05.2026.

4. Having regard to all the attending circumstances, we direct the Maharashtra State Road Development Corporation to finalise the fresh tender subject to the conditions imposed by the High Court by 08.06.2026 and submit a report in a sealed cover before the High Court. The follow-up action will depend upon the outcome of those proceedings.

5. The Special Leave Petition is, accordingly, disposed of. Pending applications, if any, stand closed.
