OFFICE REPORT

Pursuant to this Court's order dated 02.07.2012, show cause notice was issued to both the respondents by Regd. AD on 12.07.2012. AD card duly signed has been received from Respondent No.1 but no one has entered vakalatnama/appearance on his behalf, so far. Nothing has been received in respect of Respondent No.2.

For non filing of vakalatnama/appearance on behalf of served Respondent No.1 and non-completion of service in respect of Respondent No.2. Fresh show cause notice was issued to Respondent No.2 by usual mode as well as dasti mode vide Ld. Registrar Court's Order dated 17.01.2013. Counsel for the petitioners has on 01.04.2013 filed proof of service duly served on Respondent No.2.

The matter was listed before the Court of Ld. Registrar on 3.4.2013 when the Court was pleased to pass the following Order:-

"Service is complete. It is submitted that advocate Mr.Punit Taneja has been instructed to appear on behalf of respondent No.2. Seeks four weeks time for filing vakalatnama and counter affidavit.

List the matter on 3.07.2013."

For non-filing of appearance on behalf of both the respondents the matter was listed before Ld. Registrar's Court on 03.07.2013, when the following order was passed:

"Service is complete. The counsel who offered to appear on behalf of respondent No.2 on last occasion has not filed Vakalatnama and counter affidavit. No appearance also. No further steps. List the matter before the Hon'ble Court, as per Rule."

It is lastly submitted that as directed vide Ld. Registrar Court's order dated 03.04.2013, Mr. Puneet Taneja, Advocate has on 27.08.2013 filed vakalatnama/appearance on behalf of Respondent No.2 but he has not filed counter affidavit. No one has entered vakalatnama/appearance on behalf of Respondent No.1 though served with notice.

Service is complete.

The matter alongwith application above-mentioned is listed before the Hon'ble Court with this Office Report.
