ORDER

This is an application for bail filed in respect of SLP(Crl.)No.7446 of 2009, which is being heard along with applications for bail made in 21 other (in all 22) connected matters.

The petitioners, having been sentenced to undergo a period of six months simple imprisonment on account of conviction under Section 138 of the Negotiable Instruments Act, have already undergone more than five months of the sentence. This is common in all the connected matters.
