**UPON hearing the counsel the Court made the following  
O R D E R**

1. Leave granted.
2. Heard on the question of grant of interim relief. After hearing learned counsel appearing for both the parties and perused the provisions of Article 244(1) of the Constitution of India as well as the Andhra (Telangana Tribal Areas) Regulation, 1359-F in particular clause (2) of Regulation 1 amended in 1957 which reads thus:-

“(2) This section shall come into force at

once and the remaining provisions of this Regulation shall come into force. [In such areas as may be declared to be Scheduled Areas under paragraph 6 of the Fifth Schedule to the Constitution of India and from such dates as Government may by notification in the Official Gazette direct.]”

3. In view of the abovenoted regulations which has not considered by the High Court, the Presidential Notification issued on 07.12.1950 under Para 6(1) of the Fifth Schedule specifying the tribal area in the State of Andhra Pradesh (now in Telangana) shall prima facie prevail. Therefore, considering the aforesaid, *prima facie* in our view the Notification issued by the State Government on 25.06.2013 shall not be given effect to until final orders in this appeal

4. Hearing expedited. List the appeal in the month of February, 2026 for final hearing.
