SLP(C) No. 28745/2025

Ld. Advocate, Ms. Samriddhy Jindal, appearing on behalf of Mr. Anirudh Sangneria, Advocate-on-record has entered appearance for respondent No.1 (caveator) on whom service was incomplete and has submitted that vakalatnama has already been filed. Registry to verify and update the records. Let counter affidavit be filed within 30 days from the date of filing vakalatnama.

As per office report, Ld. Counsel for the petitioner has not filed spare copies for issuance of notice to respondent Nos.1 to 12 in terms of Hon'ble Court's order dated 15.09.2025. Today, more time has been sought.
