O R D E R

Issue notice returnable on March 22, 2012.

Ms. Bina Madhavan, advocate waives service for

Notice shall now be issued to the unrepresented
respondents.

In the meanwhile, following interim order is passed:

- (i) The Petitioner No. 1 - Government of Andhra Pradesh shall issue a general notice within a week from today calling for latest figures/details from the concerned institutions relevant to the year 2012-2013 with reference to the impact on their financial burden due to AICTE Notification dated January 22, 2010 that stipulates that management must fix pay-scales in accordance with that Notification and the notification of the State Government dated February 25, 2010 to implement the 9th Pay Revision Committee report of the State Government whereby there has been increase in the pay of non-teaching staff by 50%.
- (ii) Such institutions may submit their latest figures/details in terms of the above with the Admissions Fee Regulatory Committee (AFRC) within one

week of the issuance of the notice by the State Government.

(iii) No sooner the figures/details are received, in any case immediately after expiry of two weeks from

the date of issuance of notice by the State Government, the ARFC shall consider the same and submit its report to this Court by March 15, 2012.

Copy of such report may be made available to the institutions if they so desire.

(iv) The interim order dated January 6, 2012 shall remain operative until further orders.
