OFFICE REPORT

It is submitted that Mr. Gagan Gupta, Advocate has filed Special Leave Petition on 05.04.2016 against the Judgment and Order dated 10.12.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 5204/2010, 810/2012, 5095, 5102, 3848, 5099, 3854, 3853, 5046, 5096, 3844, 3845, 3856, 5104, 5093, 3855, 3850, 5109, 3846, 4926, 3852 of 2010 and 1073 of 2013 alongwith application for permission to file Special Leave Petition, exemption

from filing Official Translation, application for deletion of proforma respondents nos. 4-8 in RFA No. 810/2012 and 4-7 in RFA No. 5095/2010 and application for discharge of petitioner nos. 11-13 from guardianship in RFA No. 5109/2010.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased petitioner no. 1 namely Hukam Chand in RFA NO. 5102/2010, petitioner no. 1 namely Sohan Lal in RFA NO. 3848/2010 and petitioner no. 1 & 4 namely Khilu @ Khilu Ram in RFA Nos. 4926/2010 and 3852/2010 which are barred by time by 1466, 238, 531 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that SLP filed against the Order dated 10.12.2015 in RFA Nos. 3848, 3850, 3346, 5204, 5095, 5102, 3854, 3853, 5046, 5096, 3844, 3845, 5104, 5093, 5109, 3855, 5099 of 2010 is within time, whereas there is a delay of 1 day in RFA No. 810/2012, 24 days in RFA No. 4926/2010 and 25 days in RFA No. 1073/2013 in filing the SLPs. Further there is a delay of 69 days in refiling the SLPs. Thus there is a total delay of 70, 93 & 94 days in filing and refiling the Special Leave Petition.

It is further submitted that notice in SLP (C) Nos.9582-9583 of 2016 Entitled Kamlesh Versus State of Haryana & Ors. Etc. arising out of common order was directed by the Hon'ble Court on 06.05.2016. SLP is pending after notice (Copy of order dated 06.05.2016 is enclosed herewith).

The matter is, therefore, listed before the Hon'ble Court with this office report.
