UPON hearing the counsel the Court made the following
O R D E R

1. The petitioner seeks enlargement on bail in Crime No.58/2025 registered at Police Station Excise Circle Pandri, District Raipur, Chhattisgarh for the offence punishable under Sections 34(2) and 59-A of the Chhattisgarh Excise Act.
2. The allegations are that the petitioner was caught with 104.25 bulk liters of different types of foreign made liquor, which was in violation of the provisions of the Chhattisgarh Excise Act, referred to above, whereunder the maximum punishment is three years.
3. The petitioner was arrested on 16.06.2025. He does not have criminal antecedents. The conclusion of trial will take some reasonable time.
4. Having heard learned counsel for the parties, but without expressing any opinion on the merits of the case, the petitioner is directed to be

released on bail subject to his furnishing bail bonds to the satisfaction of the Trial Court.

5. The Special Leave Petition is, accordingly, disposed of.

6. All pending applications, if any, also stand disposed of.
