5. Even for a higher delay in filing the appeals before the High Court under Section 74 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, we have allowed the appeals before us by condoning the said delay.
6. Accordingly, the impugned orders stand set aside in terms of the aforesaid judgment and the appeals are allowed.
