UPON hearing the counsel the Court made the following

O R D E R

1. Before us are two sets of cases assailing the constitutionality of the Citizenship (Amendment) Act, 2019. Initially, *vide* an order dated 22.01.2020, these matters were sub-categorised in two groups pertaining to: (i) Assam and Tripura; and (ii) the rest of the States. After considering the brief oral submissions tendered on behalf of the parties, we find that, in the interest of ease of appreciation of the complex issues, it would be appropriate if a separate hearing is granted to the matters concerning the States of Assam and Tripura. Such hearing can be held immediately after hearing the main case. Consequently, the learned Nodal Counsel, who were appointed by virtue of the orders dated 31.10.2022 and 19.03.2024, will identify and categorize the matters into their respective groups. These lists shall be submitted to the Registry within two weeks.

2. The Registry shall thereafter segregate the matters under the two categories and list the same in *seriatim* for final hearing in the week commencing 5th May, 2026. The petitioners shall be heard on 5th May, 2026 and for the first half of 6th May, 2026. The remainder of 6th May, 2026 and the first half of 7th May, 2026 shall be allocated to the respondents. Finally, rejoinder submissions, if any, shall be heard for half of 12th May, 2026. The Nodal Counsel shall coordinate with the various arguing counsel to agree upon an internal arrangement for the sequence of their arguments.

The convenience compilations, as well as the written submissions, have been brought on record by the parties. We, however, grant liberty to place on record any new/additional material information/documents, if any, along with an additional note of written submissions within four weeks. However, there shall be no repetition of the written submissions already on record.
