O R D E R

Delay condoned.

Having heard learned counsel for the parties and considering the impugned order, this Court is of the opinion that the recourse adopted in the impugned order does not command to us, in particular, looking to the orders passed by this Court in SLP(C) Diary No. 7213 of 2023 (*Union of India & Ors. v. Siemens Ltd. & Ors.*), SLP(C) Diary No. 9725 of 2023 (*Union of India & Ors. v.*

Colgate Palmolive (I) Ltd.) and SLP(C) No. 9063 of 2023 (Union of India & Ors. v. Cummins India Limited).

In our view, in the light of the orders passed in the said cases, the order impugned is liable to be set aside and the matter is remitted back for fresh consideration by the Bombay High Court. Accordingly, this Special Leave Petition stands disposed of. The order impugned is hereby set aside. The parties are at liberty to raise all contentions before the High Court and the High Court shall pass appropriate order taking note of all the contentions on merit.

Pending application(s), if any, shall stand disposed of.
