**UPON hearing the counsel the Court made the following  
O R D E R**

- 1 Notice shall issue in those petitions where notice has not already been issued.
- 2 IA No 169187 of 2022 in Writ Petition (C) No 1546 of 2019 for substitution is allowed.
- 3 On 22 January 2020, notice was issued by this Court in a batch of cases challenging the validity of the Citizenship Amendment Act (CAA). The rules

have been recently notified. This has given rise to applications for stay.

- 4 The Solicitor General submits that four weeks' time may be granted to file a response to the applications for stay at this stage. The request for four weeks' time is opposed on the ground that in the meantime, if citizenship were to be granted that process is liable to be irreversible.
- 5 Bearing in mind all the facts and circumstances, we direct that the proceedings be listed on 9 April 2024.
- 6 On the applications for grant of stay, all counsel appearing on behalf of the applicants shall file one note of submissions not exceeding five pages by 2 April 2024. The respondents shall then have time until 8 April 2024 to file a note of their written submissions not exceeding five pages.
- 7 In the batch of cases dealing with the States of Assam and Tripura, Mr Ankit Yadav, counsel for the petitioner and Mr Kanu Agarwal, counsel for the respondents shall be the nodal counsel.
- 8 List the batch of cases on 9 April 2024.
