- 1) Learned Advocate General for the State present in the Court, submits that he has discussed with the officers to take a recourse; however, due instructions have not been

received. It is urged by him that in case the matter is listed after four weeks, possibility to find out some resolution may not be ruled out.

Rest of the matters

1) Learned counsel appearing for the respondent submits that special leave petition (SLP (C)Diary No. 71468 of 2025) arising out of order dated 05.05.2025 passed by the High Court in FAO No. 257 of 2018 has already been dismissed by this Court *vide* order dated 23.01.2026. In the said order, the High Court has relied upon the order dated 19.03.2025 passed in FAO 509 of 2014 and batch, therefore, these special leave petitions may be dismissed.

2) Learned Advocate General submits that while passing the order of dismissal, the order by three Judges Bench has

not been considered. However, the case requires consideration and an affidavit be filed by the counsel for the petitioner within a week. The respondent is at liberty to file reply within a week thereafter.

4) In the meantime, the petitioner shall take appropriate steps to serve the unserved respondents.
