The petitioner (wife) seeks transfer of the Petition for Divorce bearing H.M.A. Case No.331/2021 titled "Vikas Yadav @ Bittu Yadav vs Namrata Singh" filed by the respondent (husband) under Section 13 of the Hindu Marriage Act, 1955, which is pending before the Court of Principal Judge, Family Court, Etawah, Uttar Pradesh.

The petitioner (wife) seeks transfer of the above-stated case to the Court of Principal Judge, Family Court, South-West, Dwarka Courts, New Delhi.
