OFFICE REPORT ON DEFAULT

The matters above-mentioned were listed before the Ld. Registrar Court on 01.09.2016, when the Court was pleased to pass the following Order:-

“In SLP(C) No.10444/2015, Mr. Ajay Choudhary, Ld. counsel has filed vakalatnama for the respondent No.4 and Mr. P.N. Razdan, Ld.counsel has filed counter affidavit on behalf of the said respondent. Both the counsel has failed to clarify the position in spite of last chance granted. Therefore, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further directions. Await orders and list thereafter.
