OFFICE REPORT

The matters above-mentioned were listed before the Ld. Registrar Court on 21.07.2016, when the Court was pleased to pass the following order:-

"SLP(C) No. 10444/2015

Four weeks time as last chance is given to the Ld. Counsel for the petitioner to take fresh steps for the service of notice to the unserved respondent No. 1.

Mr. Ajay Choudhary, ld. Counsel has filed vakalatnama for the respondent No. 4 and Mr. P.N. Razdan, Ld. Counsel has filed counter affidavit for the said respondent. Four weeks time as last chance is given to them to clarify the position vide order dated 28.4.2016.

SLP(C) No. 14763-14764/2015

The respondent Nos. 1-4 in both the SLPs have failed to file the counter affidavit within the period stipulated under the rules. Four weeks time as last chance is given to the Ld. Counsel for the petitioner to take fresh steps for the service of notice to the unserved respondent Nos. 5-9 in SLP(C) No. 14764/2015. List the matter again on 01.9.2016.

SLP(C) No. 10444/2015

It is submitted there are total 4 respondents. Advocate for the petitioner has not taken fresh steps for service on respondent No. 1 so far. Mr. Ajay Choudhary, Advocate who has filed vakalatnama on behalf of respondent No. 4 and Mr. P.N. Razdan, Advocate who has filed counter affidavit on behalf of respondent No. 4 have not clarified the position, so far. Service on respondent Nos. 2 & 3 is complete by AD but none has entered appearance on their behalf.

Service is Incomplete on respondent No. 1.

SLP(C) No. 12380/2015

It is submitted that pursuant to Court's order dated 07.05.2015, the matter has been tagged with SLP(C) No. 319/2015. This is a fresh matter.

SLP(C) Nos. 14763-14764/2015

It is submitted that there are 4 respondents in SLP No. 14763/2015 and 9 respondents in SLP No. 14764/2015. Respondent Nos. 1-4 are common in both SLPs. Mrs. Ruchi Kohli, Advocate for common respondent Nos. 1-4 in both the SLPs has been declined to not file counter affidavit, vide orders quoted above. Advocate for the petitioner has not taken fresh steps for service on unserved respondent Nos. 5-9 in SLP No. 14764/2015.

Service is incomplete on respondent Nos. 5-9 in SLP No. 14764/2015.

The matters above-mentioned are listed before the Id. Registrar Court with this office report.
