Mr. Ajay Choudhary, Advocate had earlier entered appearance on behalf of respondent No. 4 but Mr. Pashupati Nath Razdan, Advocate has filed counter affidavit on behalf of respondent No. 4 without filing vakalatnama on his behalf, despite the advocate informed in this regard vide letter dated 28.09.2015. Service on respondent Nos. 2 & 3 is complete by AD but no one has entered appearance on their behalf.

Service is incomplete on respondent No. 1.

SLP(C) Nos. 14763-14764/2015

It is submitted that there are 4 respondents in SLP No. 14763/2015 and 9 respondents in SLP No. 14764/2015. Respondent Nos. 1-4 are common in both the SLPs.
