The present Transfer Petition has been filed under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of Case being F.C.O.P. No. 496 of 2019 titled as "*Singhi Kailash Kumar vs. Nitu Singhi*" pending before the Court of XII Additional District-cum-Family Judge, Guntur at Andhra Pradesh to the competent Family Court, Tirunelveli at Tamilnadu.
