O R D E R

We have perused our earlier order dated 20th January, 2025. Time of two months was given under the said order to the respondent/Company to deposit with the High Court the entire amount received by it under the Award. Time of two months has expired on 19th March, 2025. *Prima facie*, it appears to us that the respondent/Company has committed a wilful breach of the order dated 20th January, 2025. We requested the learned senior counsel appearing for the

respondent/Company to place on record the names of the Directors of the respondent. He has accordingly placed on record the names and addresses of the Directors.

Accordingly, we issue notice to Shri Ashok K. Sanghani, Managing Director, Shri Bharat K. Sanghani, Director and Shri Parag Sawant, Additional Director of the respondent/Company, calling upon them to show cause why they should not be punished for committing civil contempt. The notice is made returnable on 20th May, 2025. A copy of this order shall accompany the notice. The address details of the noticees supplied by the learned counsel for the respondent are as under:
