O R D E R

C.A.No. 2762 of 2012

Delay in filing ad-valorem court fee is condoned.

Appellant has filed statement of case but sole respondent has not filed statement of case and statutory period has expired.

C.A.No. 10147 of 2014

Last opportunity of three weeks' time is granted to the appellant for filing court fee. Registry to process for listing immediately thereafter before Hon'ble Court if court fee is filed and if not filed before Hon'ble Judge-in-chambers for further directions.

C.A.Nos. 150, 650, 721 and 4316 of 2015

Parties have not filed statement of case nor is mandatory as per amended rules.

Last opportunity of three weeks' time is granted to the appellant for filing affidavit of valuation. Registry to process for listing immediately thereafter before Hon'ble Court if affidavit of valuation is filed and if not filed before Hon'ble Judge-in-chambers for further directions.

C.A.No. 1141 of 2015

Statement of case has not been filed by the parties nor is mandatory as per amended rules. As such, process for listing the matter before Hon'ble Court.

C.A.No. 1332 of 2013
