C.A. No. 2762 of 2012

The matter above-mentioned was listed before the Ld. Registrar's Court on 8<sup>th</sup> April, 2015, when the following order was passed:-

"Service of the sole respondent is complete but none has come present. However, affidavit of valuation is yet to be filed by the appellant. In fact, the deposit of court fee of Rs. 1750/- in each of these matters is still to be made by the petitioner. Be made within three weeks time. After the necessary deposit and the filing of the affidavit in this respect, Registry to process to list the matter before the Hon'ble Court as per Rule."

It is submitted that Counsel for the Appellant has not filed the Ad Valorem Court fee of Rs.1750/- till date.

It is also submitted that Counsel for the Appellant has filed Statement of Case but Counsel for the Respondent has not filed Statement of Case till date.

C.A. No. 1832 of 2014

It is submitted that Notice of Lodgement of Petition of Appeal could not be served on the sole respondent for want of latest and correct address. Counsel for the Appellant has been informed for the same but she has not furnished the latest and correct address of the sole respondent so far.

Service is incomplete.

C.A. Nos. 10146 and 10500 of 2014

It is submitted that there is sole respondent in all the matters above-mentioned and is represented through counsel.

Service is complete in all the matters.

It is further submitted that Counsel for the Appellant has paid Ad Valorem Court fee of Rs. 2,93,000/- and Rs. 77,000/- in C.A. Nos. 10146 and 10500 of 2014 respectively. But total court fee required in C.A. Nos. 10146 and 10500 of 2014 is Rs. 3,21,000/- and Rs. 1,05,000/- respectively. She has been informed for the same but she has not done the needful so far.

C.A. No. 150 and 721 of 2015

It is submitted that there is sole respondent and is represented through counsel.

Service is complete.

It is further submitted that Counsel for the Appellant **has not filed the Ad Valorem Court fee as per new Amended Rules, 2013** till date.

C.A. No. 1141 of 2015

It is submitted that there is sole respondent.

Counsel for the Appellant has on 2<sup>nd</sup> June, 2016 furnished the fresh and complete address of the sole respondent. Fresh NLPA was issued on 14<sup>th</sup> June, 2016.

Certificate of Service is awaited.

The matters above-mentioned are listed before the Ld. Registrar's Court for orders.
