 O R D E R

It is pointed out that the title suits as referred to in the order dated 19.08.2020, which were supposed to be taken up for expeditious proceedings and to be decided within a period of six months, have not registered any substantial progress.

It is also pointed out that the suits are now pending in the

Court of Additional Senior Civil Judge, Kukatpalli and are registered as Original Suit Nos. 588, 589, 590 and 591 of 2022.

Having regard to the orders already passed in this matter, we would expect the said Trial Court to send a specific report as regards progress of the suits as also to assign them specific priority so as to conclude the trial at the earliest, preferably before 31.03.2023.

A report as regards progress may be sent by the Trial Court within four weeks from today.
